WHAT TO DO NEXT...

ONBOARD NEWLY LICENSED AGENTS

Once licensee is active with the <u>New Jersey Real Estate Commission (NJREC)</u> and have an active license reference number, applicants must email executed <u>NCJAR & GSMLS Applications</u> to <u>Membership@ncjar.com</u> or simply APPLY ONLINE with <u>NCJAR's Online New Member Application</u>.

Please make sure applications are fully executed before sending. After the application has been approved and processed, licensees will receive a NCJAR's welcome email with instructions to attend a mandatory Orientation Class.

After joining the GSMLS, you will receive an email within 24-48 hours with your GSMLS Agent ID # and instructions to pay their participation fee and register for their mandatory computer class.

- Supra eKey's can be issued at any one of our board offices within 24 to 48 hours of registration with the GSMLS and after paying their participation fee or by calling the GSMLS directly (973-898-1900).
- After completing your GSMLS membership registration, you can follow the steps below to obtain your Supra eKey:
 - Login to GSMLS
 - Navigate to AGENT/OFFICE MGMT > Supra > New Supra eKey >
 - Confirm your Office Info/Agent Info is correct
 - Select REQUEST AUTHORIZATION
 - Review account information
 - Confirm you have read the GSMLS Rules & Regulations for Keybox System
 - Enter your First, Last Name and Date
 - Select Save
 - o Status will indicate Pending Broker Authorization
 - ** Your Broker of Record or Office Branch Manager will then need to login to approve your eKey Authorization Request.

TRANSFER AGENTS TO YOUR OFFICE

- Once your new broker has transferred your license to the new office, you will fill out NCJAR's
 <u>Transfer Form</u> and have it signed by your new broker. The cost for this service is \$25 payable by
 Visa, Discover, Amex or MasterCard. Once complete, email transfer form to
 <u>Membership@ncjar.com</u>.
- Reminder: The GSMLS must be notified of this transfer and their form can be found below. This
 form must be signed by your Broker or Office Manage and sent to NCJAR. We will then sign and
 forward it directly to the GSMLS for you. GSMLS Transfer Form
