- 4. Once you are active with NCJAR, you will receive a welcome email with your NRDS ID number and assigned orientation date. If you cannot attend the assigned date, you must contact us by phone/email to reschedule.
- 5. The Supra eKey can be issued within one business day (24 hours) of GSMLS activation.

Applicants for REALTOR® membership shall complete an orientation program on the Code of Ethics of not less than 2 hours and 30 minutes of instructional time. This requirement must be satisfied within 60 days of NCJAR membership registration. NCJAR's orientation program meets the learning objectives and minimum criteria established by the National Association of REALTORS®. Your membership privileges, which may include MLS and Supra access, will be suspended for non-compliance if orientation is not completed within 60 days.
